- (3) Applications which contains alterations or erasures, or which are not fully completed, will not be considered.
- (4) If an applicant for a permit provides any false information in connection with the application, the controlling authority concerned may refuse such application and any future applications made by the same applicant.

When the goods are to be exported by air, rail or road, this permit must be produced to the Customs and/or Railway Authorities together with the Bill of Entry Export.

DIRECTOR: IMPORT AND EXPORT CONTROL

The original should be forwarded by the exporter to the Controller, South African Customs, P O Box 1154, Maputo.
